Welcome to Holiday World & Splashin' Safari! We hope this Guide will assist you while planning for and during your visit.

This Guide was compiled in cooperation with the Easterseals Rehabilitation Center of Evansville, Indiana, to assist Guests in choosing rides and slides to enjoy during their visit. Holiday World & Splashin' Safari's Ride Admission Policy is based on our ride manufacturers' recommendations plus evaluation of each attraction using our experience with and knowledge of the ride in both normal and emergency operating conditions. Our prime consideration is the ability of each person to endure the dynamics of a ride without risk of injury to that person or other riders.

Ride delays may occur while riding and members of your party may be required to remain in the riding position until the ride is restarted or Guests are escorted off the ride. All Guests should be aware that, although rare, there is always the possibility that a ride evacuation could occur due to an unplanned shutdown, inclement weather conditions, or a power interruption. If a ride evacuation is required, Guests may need to maneuver across catwalks and stairs from the highest point of the ride and down steeply inclined walkways.

Guests requiring assistance during a ride evacuation may be escorted last in order to expedite the evacuation process. While these occasions are rare, Guests should be aware of this possibility and exercise good judgment before boarding rides and slides. Please inquire about specific procedures prior to boarding or participating in an attraction. The roller coasters, water coasters, Frightful Falls, and rides that leave the ground are more likely to be evacuated during a ride shutdown. Guests with limited mobility should be accompanied by a person capable of helping to evacuate them during a ride shutdown if assistance is requested by Management.

Please observe all warnings outlined in this Guide. Management at Holiday World & Splashin' Safari reserve the right to adjust any of the restrictions listed in this Guide. If you have any doubts about an attraction's appropriateness for the individual, please have someone in your party speak to a member of Attractions Management.

The Management of Holiday World & Splashin' Safari reserve the right to deny Guest access to a ride which Management deems unsafe for the individual. Any Guest who does not fit properly in the ride restraint will not be permitted to ride.

### **AIR-CONDITIONING**

To cool off in air-conditioned comfort during your day, visit Santa's Merry Marketplace, or Plymouth Rock Café; another option is to take a ride on Gobbler Getaway (height, weight, and physical restrictions apply on this ride) in Holiday World. Our centrally located First Aid building is also air-conditioned.

### AMERICAN SIGN LANGUAGE SERVICES

Complimentary sign language interpretation services may be available. Arrangements for sign language interpreters should be made at least two weeks prior to your visit. ### **CALMING ROOM**

A Calming Room is available for our Guests who will benefit from a quiet, relaxing break from the park's sensory stimulation. The room, which includes bean bag chairs, a small tent, rocking chair, couch, plus adjustable lighting and music, is located inside our First Aid building (in Splashin' Safari's plaza). The Calming Room may be reserved on a first-come, first-served basis for 30-minute sessions at Guest Relations, Holiday World Services, or First Aid.

### **EVACUATIONS**

Evacuations may be required due to mechanical problems, weather conditions, or a power interruption. If an evacuation is required, riders may need to maneuver across walkways from the highest point of the ride, and down steeply inclined catwalks or steps. Ride vehicles may also stop at the top of a lift or on the ride course due to mechanical reasons. Certain evacuations may require riders to use additional safety equipment during the process. Remain seated until given instructions. If an evacuation from an attraction is required, for safety reasons, we may evacuate ambulatory riders prior to evacuating those riders using wheelchairs. Is so, you accept any risk due to delayed evacuation if we need to physically lift or lower you.

### **FAMILY RESTROOMS**

Family Restrooms are located in Santa's Merry Marketplace, next to the Christmas Fountain, near Thunderbird, in Stuffing Springs near Good Gravy!, in First Aid, between Safari Pizza and Locker Rental, between Jungle Jake's and Safari Sam's SplashLand, between Bahari Wave and Bahari River, in the Party Plaza, and in the Legend Parking Lot. Please check a park map for other restrooms.

### **FIRST AID**

An air-conditioned First Aid Station is accessible from both parks and is centrally located between the Thanksgiving bridge and the Splashin' Safari lockers. Please use this location if a flat surface is needed to help change diaper-dependent Guests.

### **FREE WATER & SOFT DRINKS**

Free unlimited water and soft drinks are available at any restaurant or Pepsi Oasis location in the park.

### **LOST ITEMS**

Never attempt to recover an item lost while riding or in a restricted area. Notify a Ride Operator for assistance, and we will do everything we can to recover your property as quickly as possible. All items found at Holiday World are turned into our Lost and Found Department near the Front Gate. Please note: items may not be recovered until the next day or they may not be found. Lost articles may be reported online at: HolidayWorld.com/Lost

### **MAGNETIC FIELDS**

Magnetics are used at the following attractions: Thunderbird, Good Gravy!, Wildebeest, and Mammoth. Guests with medical devices sensitive to magnetic fields (pacemakers, hearing aids, etc.), should consider these factors when deciding to ride.

### PARKING

Free parking for Guests with disabilities is available on a first-come, first-served basis near the Front Gate in the Raven Parking Lot and at the east end of the Legend Parking Lot.

### PHOTO SENSITIVITY/STROBE LIGHTING

Many attractions utilize special effects including strobe lighting, photography flashes, and specialty ride lights that may impact Guests with certain medical conditions. Some rides that utilize these effects include: Good Gravy!, The Voyage, Thunderbird, Gobbler Getaway, Frightful Falls, Revolution, HallowSwings, Star-Spangled Carousel, Wildebeest, and Cheetah Chase.

### PREGNANCY

Guests who know or believe they may be pregnant should follow all rules, guidelines and restrictions listed for each ride. Those who are pregnant should not ride a ride that specifically lists pregnancy as a ride restriction. Please review all rules and guidelines at the entrance of each ride.

### **PROSTHETIC DEVICES**

Guests with any type of prosthesis should not ride unless they can ensure the device is properly secured and will remain in place during the ride. All riders must be able to maintain the proper riding positioning. Leg prosthetics are not allowed on HallowSwings, Thunderbird, and Crow's Nest.

### RESTAURANTS

Wheelchair/ECV-accessible seating is available at each restaurant (check a park map for locations). Please be aware that our venues offer counter service; Team Members are available to assist upon request. Service animals are permitted in all restaurants.

### **RIDE ACCESS**

In Holiday World, most accessible entrances are located at the ride exit; exceptions are Thunderbird, which has an accessible queue and Holidog's Treehouse, which has an accessible entrance located at the base of the tower closest to Kitty's Tea Party. Just for Pups and Magic Waters do not have specific entry or exit points. Guests needing special ride boarding arrangements due to physical limitations should request a Ride Boarding Pass at Holiday World Services. Please do not hesitate to hold up your Ride Boarding Pass when you arrive at the ride's exit gate (or designated accessible entrance) to alert the Ride Operator.

### **(OBTAINING A) RIDE BOARDING PASS**

Ride Boarding Passes are issued for Guests with limited mobility and other special circumstances at Holiday World Services.

### **SEGWAYS® & GOLF CARTS**

Due to varying terrain and pathway configurations, as well as crowds that include small children and strollers, we regret that we cannot permit the use of golf carts or two-wheeled, self-balancing electric vehicles (i.e. Segways), in Holiday World & Splashin' Safari. Guests' personal wheelchairs and Electric Convenience Vehicles (ECVs) are permitted and are also available for rent on a first-come, first-served basis at St. Nick's Rentals in the Christmas section.

### **SHOPS**

Please ask a Team Member for assistance in obtaining any hard-to-reach items.

### **SPECIAL DIETARY NEEDS**

Guests with special dietary needs and Guests with infants will be accommodated. Please see a Security Officer at the Front Gate for assistance. Several of the park's restaurants offer allergen-friendly and gluten-free meals and snacks. See HolidayWorld.com/Food for details.

## **GENERAL INFORMATION**

## **CASTS AND BRACES**

Guest with casts and braces will be restricted from riding rides where the cast or brace will not fit inside the ride unit or where it will present a hazard to the Guest or others. Guests with full arm (elbow restricted) and full leg (knee restricted) casts or braces are restricted from most rides. We suggest you delay your visit until the cast is removed.

The following chart displays the cast and brace rules for all rides and attractions.

- F Must ride in a specific location.
- X May not ride with the brace/cast.

If an attraction is blank or not listed the Cast/Brace must fit safely in the ride unit/attraction.

## **RIDE BOARDING PASS**

Ride Boarding Passes are available for Guests with limited mobility who cannot otherwise navigate queues, and for Guests with other special circumstances. To be issued a Ride Boarding Pass, Guests should go to Holiday World Services. Each Guest who requires an accommodation will need his or her own Ride Boarding Pass. Each Pass will accommodate up to three accompanying family members, caretakers, and/or companions. One or more of the accompanying Guests should be physically able to assist the Guest with transferring on and off the ride if help is required. Ease of boarding rides varies and must be taken into consideration when deciding which rides to ride. Most rides will require that a Guest using a wheelchair/ECV transfer on and off the ride.

The Guest to whom the Boarding Pass was issued must ride in order for the accompanying Guests to take advantage of the Ride Boarding Pass. If the Guest who was issued the Pass chooses not to ride, their party must wait in the ride line.

We recommend that Guests needing assistance transferring from a wheelchair/ECV onto a ride visit with a companion. Our Ride Operators/Attraction Attendants will provide information and answer questions however they are not specially trained to assist in transferring a Guest to and from a ride vehicle and may not be able to do so.

Please find your Ride Boarding Pass on Page 62. The rides listed require a specific boarding time. Those not listed do not require a specific boarding time.

## **RIDE BOARDING PASS**

### **IF YOUR PARTY EXCEEDS FOUR RIDERS**

When the riding party totals more than four, the majority of the group should get in the ride line. The Ride Boarding Pass holder, along with one other member of the group, should go to the ride exit with the Ride Boarding Pass and explain to the Ride Operator/ Attraction Attendant that part of the group is already standing in line. Guests using the ride exit for boarding should wait until their group is nearing the front before approaching the exit. Guests are asked to please not block the exit while waiting.

By choosing this method, the Ride Boarding Pass will serve as a placeholder in line for the Ride Boarding Pass holder. To ensure a smooth experience for all Guests, it is preferred that you follow this process consistently throughout the day and disregard the process outlined below for four riders or less.

### **IF YOUR PARTY IS FOUR RIDERS OR LESS**

- 1. Upon arrival at the park, Guests should proceed to their first attraction of the day and head to the ride's exit.
- 2. The Guest and their party (maximum of 4 Guests, including the Guest who was issued the Ride Boarding Pass) will ride the attraction.
- 3. After riding, Guests receive a "buffer time" based on the current length of the line for that attraction. This buffer time acts as a virtual wait for the next attraction.
- 4. During the buffer time, Guests are free to explore other areas of the park while they wait for their next ride opportunity.
- 5. Once the buffer time is up, Guests may head to their next attraction and repeat the process. Guests may only have one active buffer time at a time.

## **RIDE SAFETY AND ACCESSIBILITY**

The safety of Guests and Team Members is the #1 priority at Holiday World & Splashin' Safari. Safety is a shared partnership between the park and our Guests. Holiday World & Splashin' Safari reserve the right to refuse any Guest access to a ride which Management deems unsafe for the individual. Please carefully review and consider the requirements and restrictions of our attractions (listed in this Guide and at our attractions) to determine if you or members of your party can safely participate.

### Please also note:

- Theme park and water park attractions expose riders to forces, speeds and other intense elements that may cause distress or injury to persons with pre-existing health conditions. Guests should consider these elements when determining the suitability for all riders.
- All riders must be in good health to ride. We recommend that Guests with any medical condition that may be affected by a ride carefully heed the warning signs at each ride entrance.
- In order to ride, Guests must be able to use seats and/or safety restraints properly and understand and follow verbal and/ or written safety procedures. Guests must also be able to demonstrate a willingness and ability to comply with verbal and written ride requirements.
- Guests must be able to maintain the proper riding position throughout the ride including sitting upright and maintaining control of upper torso, head, and neck as instructed in this Guide. Guests must also be able to use the restraint devices properly and hold on (or grip/brace) when required. Where applicable, Guests must keep their heads against the headrests, with arms, hands, legs, and feet down and inside the ride vehicle. Children must be supervised at all times.
- Unless otherwise indicated, one Guest may not ride on another Guest's lap.

## **RIDE SAFETY AND ACCESSIBILITY**

- Guests with prosthetics, casts, or braces may be restricted from riding certain rides where the prosthetic, cast, or brace may present a hazard to the Guest or other riders. When a cast or prosthetic is permitted on a ride, it must fit comfortably within the ride vehicle and not interfere with the required riding position (including holding on) or function of the restraint, as applicable. Additional information on casts and prosthetics may be found in the ridespecific information on the following pages.
- Hearing devices and other electronic devices may be damaged by water on water rides. Please take necessary precautions to protect these items. Due to the fact that many rides vibrate, Guests should take necessary precautions to protect hearing devices and eyeglasses on all rides.
- For everyone's safety, Guests must ensure artificial limbs are secured or removed before boarding. If riding on a water slide, any sharp edges must be covered. Please be advised if a Guest has two prosthetic legs which are removed for safety reasons, height restrictions could prevent the Guest from riding.
- Height requirements are posted at each ride. All Guests, including those using wheelchairs/ECVs, must meet the height requirement. Guests may be officially measured at the Height Measurement Station in Holiday World or Splashin' Safari (during water park operating hours) to receive an appropriate wristband. Holiday World Services in the Christmas section is available when the Height Measurement Station in Holiday World is closed and is available when the Height Measurement Station in Splashin' Safari is closed.
- Most attractions require the transfer from a wheelchair to the ride. Select attractions have transfer devices or transfer seats available. Guests may remain in their wheelchair to ride Holidog Express, Star Spangled Carousel, and to explore Holidog's Treehouse. Attraction access for each ride/attraction is detailed in this Guide.

## **RIDE SAFETY AND ACCESSIBILITY**

Every attraction entrance lists rider requirements including height and special safety instructions. Additional information, including minimum extremities, additional cast requirements, and other ride accessibility information for each attraction, is included in this Guide. Holiday World & Splashin' Safari use the following terms:

**SUPERVISING COMPANION:** defined as any Guest who is at least 16 years of age and meets the rider requirements to ride alone. Supervising Companions are responsible for the behavior of the Guest they accompany and must generally help the Guest while loading and unloading the attraction, assist in maintaining postural control while the attraction is in motion, and assist the Guest down stairs, walkways, or steeply inclined ramps in the event of a ride evacuation.

HAND-HELD INFANT: defined as a young child who is unable to walk to the attraction independently or maintain independent seated postural control. Also called "lap baby."

**FUNCTIONING ARM:** Arm with remnant to the elbow and the ability to grip or brace.

**FUNCTIONING HAND:** Arm with an elbow and a hand. Hand must have the ability to grip and brace. A prosthetic may be used unless otherwise stated.

**LEG:** Leg with a knee and remnant to the ankle. A prosthetic may be used unless otherwise stated.

**LEG REMNANT:** Leg remnant at or below the knee unless otherwise defined in this Guide.

## **GENERAL INFORMATION**

## **RIDER REQUIREMENTS**

All restraint systems, including lap bars, shoulder harnesses, safety chains, and seatbelts must be positioned and fastened properly to allow Guests to ride. Guests who do not fit properly within any safety restraint will not be permitted to ride.

Due to restraint system requirements, Guests of larger size (in terms of height, weight, and/or proportions) may not be accommodated on some of our rides. Maximum weight limits are posted at many Splashin' Safari attractions and in this Guide.

Test seats are available at Good Gravy! and Thunderbird. On other rides, Guests may go up the ride's exit to ensure restraints fit properly before waiting in line.

The manufacturer requires a maximum Guest height on the following rides: Thunderbird and Revolution.

## **INDIANA PATRON RESPONSIBILITY**

Indiana Administrative Code Title Title 675 Article 31-2-4 requires the following of amusement device patrons:

- Patrons have a duty to not participate in or on any amusement ride, device or attraction when under the influence of drugs or alcohol.
- Patrons have a duty to properly use all ride or device safety equipment provided.

## **OXYGEN TANKS ON RIDES & SLIDES**

To ensure everyone's safety, oxygen tanks may only be taken on the rides listed below in Holiday World, with the following conditions:

### **CHILDREN RIDES: UNDER 54"**

*Comet's Rockets:* Guest should sit in the front seat and put the oxygen on the floor of the rocket.

Dancer's Fish: Put oxygen on the floor of the fish; ensure the tank will not tip.

*Prancer's Merry-Go-Round:* Oxygen tank must be in a backpack worn by either the rider or adult standing by the rider.

Tippecanoes: Put oxygen in the canoe; ensure the tank will not tip.

### **FAMILY RIDES**

Doggone Trail, Gobbler Getaway, Holidog Express, and Lewis & Clark Trail: Put oxygen on the floor or seat; ensure the tank will not tip.

*Cranberry Corner, Holidog's Treehouse, and Just for Pups:* Guests may play in the structure with an oxygen tank in a backpack on their back.

*Magic Waters:* Guests may play in the water with an oxygen tank in a backpack on their back.

*Star Spangled Carousel:* Oxygen tank must be in a backpack worn by either the rider or adult standing by the rider. If Guest prefers to sit in a chariot, place oxygen on the floor or seat, ensuring the tank will not tip.

Oxygen tanks are not permitted on any of the water slides but are permitted on the following attractions in Splashin' Safari: Bahari Wave, Bahari River, Muziki Bay, The Wave, and the pool areas of Kima Bay, Safari Sam's SplashLand, and Tembo Tides. Oxygen tanks must be carried in a backpack and worn by the Guest.

## **GENERAL INFORMATION**

## **SERVICE ANIMALS**

Holiday World complies with the Americans with Disabilities Act (ADA), in which a service animal is defined as a dog that has been individually trained to do work or perform tasks for an individual with a disability. The task(s) performed by the dog must be directly related to the person's disability. Emotional support, therapy, comfort, or companion animals are not considered service animals under the ADA. For safety reasons, service animals are permitted only on Doggone Trail, Gobbler Getaway, Holidog Express, Lewis & Clark Trail, Prancer's Merry-Go-Round, Star Spangled Carousel, and the Parking Lot Trams.

When riding the above rides, the service animal must sit on the floor of the ride next to where the Guest is seated. Service animals may also accompany Guests in Holidog's Treehouse. If a Guest chooses to ride a ride not listed above, the service animal must be left with someone in their party who is not riding. Team Members are not allowed to look after service animals. Although service animals are welcome in Splashin' Safari, they are not permitted in the water, this includes Magic Waters in Holidog's FunTown.

Guests are responsible for cleaning up service animal waste and for controlling the service animal's behavior. Service animal relief areas are located throughout the park; see Park Map for details.

## **SHOW VENUES**

Seating for Guests using wheelchairs/ECVs and at least one companion is available at each show venue. Seating is available on a first-come, first-served basis. Other members of the party may need to find seating nearby. Service animals are welcome at all show venues, but cannot enter the pool at Muziki Bay. Visit HolidayWorld.com/Today for daily show times. Assisted listening devices and show scripts are available upon request. Please visit Holiday World Services or speak to a theater Team Member for more information. Requests must be made at least 30 minutes prior to show start.

### **CHRISTMAS THEATER**

Christmas Theater is an outdoor venue located in the Christmas section across from Santa's Merry Marketplace. The theater has uncovered bleacher-style stadium seating. Accessible seating is available near the front and rear of the theater.

### **HOOSIER CELEBRATION THEATER**

The Hoosier Celebration Theater is an outdoor venue located in the Fourth of July section next to HallowSwings. The theater has covered bleacher-style stadium seating. Accessible seating is available near the front and rear of the theater.

### **AQUA ACTION ARENA**

Aqua Action Arena is an outdoor venue located in the Halloween section near The Raven roller coaster. The theater has uncovered bleacher-style stadium seating. Accessible seating is available near the rear of the theater.

### **MUZIKI BAY**

Muziki Bay is an outdoor venue located in Splashin' Safari near Otorongo. The theater has a pool with beach-side chair seating. See page 51 for pool accessibility information.

## **SENSORY GUIDE AND EXPERIENCES**

Holiday World & Splashin' Safari understand that sensory experiences can vary for each Guest. To ensure everyone can enjoy their visit, we've developed sensory guidelines that measure five sensitivities: Sound, Sight, Touch, Movement, and Splash. Each is rated on a scale of low, moderate, and high, so you can easily understand the sensory impact of our attractions.

### **ENTERTAINMENT**

Holiday World & Splashin' Safari offer a variety of entertainment options that may include strong sensory elements. Our stage shows feature singing and dancing, and our drone and firework spectacular, Holidays in the Sky, combines lights, sounds, and a firework finale. Additionally, in the Halloween Section we feature a performance from the Nerveless Nocks, a stunt show with loud sounds from water jet packs and motorcycles.

### **SENSORY GUIDE KEY**

Low Sensitivity (L): Minimal sensory stimulation. Expect soft sounds, gentle lighting, and/or little to no strong physical sensations. Movements are slow and controlled, with limited or no water exposure.

**Moderate Sensitivity (M)**: Moderate sensory stimulation. This may include moderate noise levels, bright lighting or occasional flashes, light vibrations, and/or moderate physical movement. Water effects may involve light sprays or mild splashes.

**High Sensitivity (H)**: Intense sensory stimulation. Expect loud sounds, flashing lights, rapid movements, strong vibrations, and/or significant water splashes. These attractions are designed for highenergy, fast-paced experiences.

## SPLASHIN' SAFARI GENERAL INFO

The pools in Splashin' Safari are staffed by certified Lifeguards trained through Ellis and Associates. To participate at Splashin' Safari, swimwear or shorts and shirts may be worn and should be modest in design (no thong swimsuits). Diaper-dependent Guests must wear swim diapers. Swim diapers are available for sale in Safari Outpost in the Splashin' Safari plaza as well as most Holiday World gift shops.

Complimentary life jackets are available at The Wave, Bahari Wave, Bahari River, and Tembo Tides. "Infant" life jacket size accommodates Guests up to 30lbs.; "Child" size accommodates Guests between 30lbs. and 50lbs.; "Youth" size accommodates Guests between 50lbs. and 90lbs.; and "Adult" size accommodates Guests over 90lbs with a chest size between 30" and 52".

Splashin' Safari has a limited number of accessible tubes available for use on Bahari River by Guests with limited mobility or who lack the ability to sit up unaided. In some circumstances, they can also be used in the wave pools. For additional information, please ask a Lifeguard to call for a member of management.

Wildebeest, Mammoth, and Cheetah Chase are included on the Ride Boarding Pass. It does not apply to the water slides, though, because their "exits" are the bottom of the slides. There are a number of water attractions—The Wave, Bahari Wave, Bahari River, Kima Bay, Safari Sam's SplashLand, Tembo Falls, and Tembo Tides—which require little or no wait.

There is a procedure for weighing Guests who are wheelchair-bound in Splashin' Safari (as weights are a factor on all three water coasters). Mammoth has been selected as the only water coaster we can do weight verifications, as a wheelchair will fit onto those scales. The scales at Wildebeest and Cheetah Chase are too narrow. The Guest will be weighed in their wheelchair at Mammoth, then asked to transfer to a seat or bench in the station (a transfer board will be available). Team Members will then weigh the wheelchair and deduct the wheelchair weight from the total weight and document it on the Ride Boarding Pass. This will need to be shown when boarding water coasters so their weight can be accurately figured into the total weight of all riders on their boat.
